

Draft Guidance on Lefamulin Acetate

Active Ingredient:	Lefamulin acetate
Dosage Form; Route:	Solution; intravenous
Strength:	EQ 150 mg Base/15 mL
Recommended Study:	Request for waiver of in vivo bioequivalence study

Waiver:

To qualify for a waiver of the in vivo bioequivalence (BE) study on the basis that BE is self-evident under 21 CFR 320.22(b), a generic lefamulin acetate intravenous solution must be qualitatively (Q1)¹ and quantitatively (Q2)² the same as the Reference Listed Drug (RLD).

An applicant may seek approval of a drug product that differs from the RLD in preservative, buffer, or antioxidant provided that the applicant identifies and characterizes the differences and provides information demonstrating that the differences do not affect the safety or efficacy of the proposed drug product.³

¹ Q1 (Qualitative sameness) means that the test product uses the same inactive ingredient(s) as the reference product.

² Q2 (Quantitative sameness) means that concentrations of the inactive ingredient(s) used in the test product are within $\pm 5\%$ of those used in the reference product.
